



### **Transforming practice development: Contributing** meaningfully to the identity of Social Work

Jo Sutherland, Principal Social Worker; Plus members of the Practice Development Team, and Social Work and Social Care Leads, Gloucestershire County Council

Often, the work of adult social workers is unrecognised by wider society. Join this session to celebrate the positive impact of adult social workers in protecting vulnerable adults from harm, and supporting adults to live the life that they choose to their upmost potential.

The session will be grounded in the theories that underpin the knowledgebase of social work, and will include how essential practice education is to ensuring that there is a highly-skilled workforce. There will be a specific emphasis on supporting a professional identity and the clear role that adult social work practitioners play in often multi-disciplinary teams.

Join this session to discover more about whether a greater sense of professional identity is crucial for the future of social work; and how social workers can be supported throughout each step of their career journey to contribute meaningfully to the identity of social work.

### Managing stress for practitioners across the public sector: Who has responsibility?



Stress is a major problem in today's pressurised workplaces, but what causes it and who is responsible for dealing with it? These are key guestions. Well-known social work author Professor Neil Thompson has been writing and teaching about stress for decades. In this presentation he warns against the oversimplified approaches to stress that are very common. He argues that tackling stress in an ill-informed way has the potential to make a bad situation worse.

### The Engage Model: How to effectively engage perpetrators of domestic abuse

Saskia Lightburn-Ritchie, Chief Executive, My CWA

In this engaging presentation, Saskia Lightburn-Ritchie, Chief Executive of My CWA, will explore the challenges that can occur when working with those who show harmful behaviours, specifically in relation to sustained levels of engagement and participant dropout rates. Drawing from both the lessons learned from our own practice and developments in research, the Engage project has been designed to provide a route to engagement with individuals who have convictions or are suspected of domestic abuse-related incidents towards an intimate partner.

Saskia will explore how the Engage project provides a solution to overcoming these key challenges through a suite of early interventions such as engaging those who harm in custody suites, offering support to those on bail as well as Engage awareness raising activities to encourage a sustained move from pre-contemplation to contemplation on the cycle of change. Engage supports the effective application of an understanding and management approach to domestic abuse support services and ultimately highlights the essential nature of engaging those who harm as a key part of domestic abuse work with families.

### The neuroscience of burnout and the impact on service user outcomes

Jan Carpenter, Qualified Social Worker and Founder, Turn Over a New LEAF

Fear-based emotions are all too common in the Social Care sector due to a range of factors. It can affect wellbeing, performance and quality of life and work, making it everyone's business.

This workshop will cover what fear is and what causes it; the nervous system's response to stress; and how to let go of fear and stress. Join Jan to develop practices that will help improve your response to stress and let go of fear-based emotions.

## How might viewing the parent-child relationship as our 'client' improve practice in children's social care?

Dr Alice Loving, Attachment, Trauma and Mentalization Specialist

This talk will give a brief overview of 3 theoretical frameworks that practitioners can apply in their practice to better understand the relational dynamics within the families they are working with. These are Attachment, Trauma and Mentalization.

Participants will explore how each of these frameworks can enhance parenting assessments and assist practitioners with methods of support that can increase the chances of positive outcomes for children and families.
